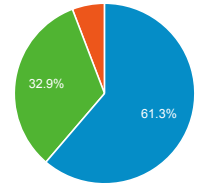

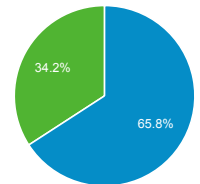
Users by Device Category
